INTRODUCTION

Thursday 8th October, 2020 signalled the beginning of the official start of General Elections in St. Vincent and the Grenadines. It was on that day the Hon. Prime Minister, Dr. the Honourable Ralph E. Gonsalves, at a virtual meeting of his Unity Labour Party, announced that he had advised the Governor General to dissolve Parliament on Friday 9th October, 2020. At that same meeting, he also announced the dates for Nomination Day and General Elections as 20th October, 2020 and 5th November, 2020 respectively.

- (i) At the conclusion of Nomination, on 20th October, 2020, three (3) Political Parties and one independent candidate, listed below, had registered their interest to contest the polls. The Unity Labour Party (ULP) led by Dr. The Honourable Ralph E. Gonsalves
- (ii) The New Democratic Party (NDP) led by Dr. Honourable Godwin Friday
- (iii) The SVG Green Party (GP) led by Mr. Ivan O'Neal, and
- (iv) Independent candidate: Mr. Osordo E. Bennett

The ULP and the NDP both presented a slate of fifteen (15) candidates, to contest in the fifteen (15) constituencies, whilst the GP presented two (2) candidates to contest for the North Central Windward and the East St. George constituencies. The independent candidate contested the South Leeward election. A total of thirty three (33) candidates contested the 2020 General Elections.

Mrs. Anesia O. Baptiste, leader of the Democratic Republican Party (DRP) which participated in the 2015 General Elections informed the Supervisor of Elections, through a Resignation Announcement dated 9th October, 2020, of her decision to resign from her job as the party's political leader and further, not to participate in the 2020 General Elections. The Supervisor thanked her for her contribution to the nation in her capacity as leader of the Democratic Republican Party and wishes her every success for the future.

At the conclusion of the General Elections, the Unity Labour Party was victorious, winning nine (9) seats, while the New Democratic Party won six (6) seats. The breakdown of the results is reflected in Appendix 1

The Electoral Office conducted the elections, according to the Representation of the People Act No. 7 of 1982. The Office is convinced that the entire process was done in accordance to this Act.

PRE-ELECTION ACTIVITIES

The Pre-Election period was focused on registration/re-registration and education of the Electorates. Registration/re-registration is a continuous process which is conducted twice per week in all constituencies. The Re-registration process intensified after the launch of the Voters' Education Programme in April, 2019. The present National Identification Card, which went into circulation in June 2009, and, which had a useful life of ten (10) years, was due to expire in 2019. A total of thirteen thousand, nine hundred and fifty-two (13,952) Identification Cards were due to expire by 31st December, 2019. The Voters' Education Programme was therefore designed to educate electorates about the importance of their Identification Cards and the need to have them updated. It also provided valuable information as to their responsibilities as voters.

With the support of Registration Officers, community meetings were held throughout the country. The information shared at these meetings was complimented with additional information shared through radio and television programs, the Government and Electoral Office websites, telephone blasts and leaflets.

The Voters' Education Programme was supported by a dedicated alliance of partners. These partners (see acknowledgement i) invested time, personnel, transportation, technical assistance and other resources which facilitated the success of the programme and the General Elections on a whole. The partnerships developed with these institutions continued as we endeavour to strengthen the work of the Electoral Office and provide greater visibility to the Vincentian people. The Supervisor of Elections and Electoral Staff is eternally grateful for their valued partnership.

During this pre-election period the Electoral staff also prepared for the General Elections.

The voters list was consistently updated through the continuous registration/re-registration process and the removal of persons who were deceased from the list. A quarterly list was also prepared and distributed to political parties and Registration Officers. These lists were also posted on the Electoral Office's Website. The Information Technology Service Department (ITSD) of the Ministry of Finance must be credited for their technical support in the development and maintenance of the website.

The existing list of Polling Stations was reviewed. These sites were visited and their availability for use confirmed. With BRAGSA's support, many of these buildings were repaired and retrofitted. Ramps were erected to provide greater access especially for the physically challenged.

The number of Polling Stations were increased by four (4), from two hundred and thirty one (231) in 2015, to two hundred and thirty five (235). The increases were North Windward – Polling station D1, Central Kingstown – Polling Station A3, and West Kingstown – Polling stations – H2 and I2. These were added to cater for the large number of voters in these Polling Divisions.

A cadre of persons were selected and trained to manage these stations. The Fifteen (15) Returning Officers were appointed by the Governor General. They in turn conducted training exercises with persons within their constituencies in an effort to staff the polling stations.

As a consequence of the Coronavirus Pandemic, additional staff was recruited and trained to provide health-related services. These recruits ensured that voters were able to exercise their franchise in a safe, healthy environment.

Further to the addition of staff, the Health Services Committee of the National Emergency Management Organization (NEMO) drafted COVID-19 Health Protocols to be implemented during the conduct of the General Elections. In addition to these protocols, The House of Assembly Election (Amendment) Rules, 2020 were introduced to cater for voters who were exempted from quarantine under the Public Health Order. These documents are attached in (Appendix 47 - 63)

The Royal St. Vincent and the Grenadines Police Force provided security throughout the entire Elections period. Their presence was a great contributor to the peaceful environment within which the Election exercise was conducted.

A Media Team was also installed. This team was led by the National Broadcasting Corporation (NBC). Its mandate was to receive, and broadcast the Election results. Tremendous work was done by the team's co-ordinator to recruit and manage the various agencies and to ensure that the quality and efficacy of the dissemination of the results were of a very high standard.

Stakeholder meetings continued quarterly. However, during the election period, there was increased engagements so as to update stakeholders on issues related to preparations, implementation matters and address any other issues that were raised.

Meetings were also held with the National Monitoring and Consultative Mechanism (NMCM). These meetings focused on clarifying and understanding of issues that were directly related to the general preparations for the General Elections and also to address questions and concerns raised by stakeholders.

The Supervisor of Elections is grateful to all who made that sacrificial contribution to ensure that the entire Elections exercise was safe and successful.

NOMINATION DAY

Nomination Day, 20th October, 2020; a total of thirty-three (33) nominations from candidates desirous of contesting the elections were received. This number represented a full slate of fifteen candidates from the New Democratic Party (NDP) and the Unity Labour Party (ULP), two (2) from the Green Party (GP) and one (1) Independent.

The nomination process was overseen by fifteen (15) Returning Officers and their Election Clerks. The day's proceedings were conducted between the hours of 9:00 a.m. and 1:00 p.m. The full slates of candidates are listed in the table below:

SPECIAL VOTERS' REGISTRATION

On Friday 09th October, 2020 the Governor General declared a fifteen (15) days Special Voters' Registration period. The period began on Saturday 10th October, 2020 and concluded on Saturday 24th October, 2020.

The fifteen (15) days registration period was intense. While it provided the opportunity for first time registrants who became eligible within this specific period to be registered, many electors who had not previously updated their registration used the opportunity to re-register. At the end of the period a total of 3,194 Electors were registered/re-registered.

FINAL VOTERS' LIST

The Final Voters' List was published on Wednesday 28th October, 2020. The printed and electronic versions were distributed to all Returning Officers and Political Parties on Monday 30th October, 2020. The list was also posted throughout the constituencies and on the Internet.

A total of ninety eight thousand, one hundred and nineteen (98,119) registered voters were on the list and therefore were eligible to participate in the 2020 General Elections.

A comparison of the last three General Elections showed that there were 89,527 registered electors in the December 5, 2015 General Elections,101,053 in the December 13, 2010, and 91, 069 in the December 7, 2005.

ELECTION DAY

On Election Day, all but one of the two hundred and thirty-five (235) Polling Stations opened on time at 7:00 a.m. While the voters at that Polling Station were delayed, they were not disenfranchised in anyway. The Supervisor of Elections thanked all parties involved for their patience and understanding.

Each Polling Station had its full complement of staff. The staff included a Presiding Officer, one or two Poll Clerks, a security and one of two sanitizers. Agents of each candidate contesting in that constituency were also present. Additionally, Polling Divisions that housed three (3) or more Polling Stations were assigned Marshalls.

These Marshalls worked on the outside as guides to ensure voters were queued correctly. The Polling Stations staff was supervised by a Returning Officer and one or more Election Clerks.

Voters turned-up early at the polls. The flow of voters was consistent and heavy up to about midday. During this period, lines were long at many of the Polling Stations. The voters were patient, peaceful and quite compliant with the instruction of the Polling Staff.

The Polls closed at 5:00 p.m. However, persons who were eligible under the House of Assembly Election (Amendment) Rules were accommodated between 5:00 p.m. and 5:30 p.m.

POST ELECTION ACTIVITIES

The final count was conducted in all constituencies on Thursday 6th November, 2020. The day began at 8:00 a.m. and continued until every ballot contained in all ballot boxes was counted.

The Returning Officers, charged with the responsibility as outlined in the Representations of the People Act (RPA) to conduct this exercise, proceeded to count, first, all valid votes awarded to the various candidates and second, all votes that were categorized as rejected during the Preliminary Count. The final count was witnessed by candidates, their representatives and local and regional observers.

The Supervisor of Elections observed the final count in North Leeward and North Windward while the Deputy Supervisor of Elections observed in North Leeward. The preliminary results in North leeward showed that Mr. Carlos James received, two thousand, two hundred and eighty seven (2,287) votes while Mr. Roland Matthews received two thousand, two hundred and eighty a difference of seven (7) votes. Additionally, there were thirteen (13) Rejects. At the end of the final count on Friday 7th November, 2020, Mr. Carlos James received two thousand, two hundred and seventy one (2271) votes to Mr Roland Matthews two thousand, two hundred and seventy (2,270). Thirty nine (39) Rejects were recorded. The completion of the day's exercises varied throughout the various constituencies.

At the end of the final count the result remained consistent with that of the preliminary count. The Unity Labour Party had won nine (9) seats to the New Democratic Party six (6) seats. It must also be highlighted that although the New Democratic Party gained only six (6) seats, they won the majority of the popular votes: thirty two thousand, nine hundred (32,900) or 50.09% to the Unity Labour Party thirty two thousand, four hundred and nineteen (32,419) or 49.35% a margin of four hundred and eighty one votes (481) or 1.01%. The Green Party received thirty three (33) votes or 0.05% while the Independent received sixteen (16) votes or 0.02%. A total of three hundred and nineteen (319) votes or 0.49 % were rejected.

At the conclusion of the final count all Writs of Election were received from the Returning Officers. The Supervisor of Elections subsequently presented the fifteen (15) Certificates of

Endorsement to Her Excellency the Governor General. Following are the results of the 5th November, 2020 General Elections.

CONCLUSION

The 2020 General Elections has concluded. There was once again an opportunity to test the election machinery and more broadly the nation's democracy. Both remained strong. As a consequence, free and fair elections were conducted and the results reflected the will of the Vincentian populace.

While the General Elections were successful it was not without its challenges. The miscommunication chiefly through social media must be single out because of its negative impact. The use of electronic devices at and in the Polling station must also be addressed as it threatens the secrecy of the ballot and facilitated Election Day campaign. Although, great effort was made especially through the Voters' Education Programme to educate the public on the entire electoral process and the activities on Election Day, some persons preferred to stay misinformed. Notwithstanding, the support for the programme was tremendous.

Additionally, the experiences gained through the exercise must serve to guide the election machinery's audit so as to ensure that it stays relevant. Hence, a comprehensive review of the Representation of the People Act No. 7 of 1982 is recommended. The areas identified by the former Supervisor of Elections are further endorsed for review. (See list below)

The Supervisor of Elections is truly grateful to the entire electoral staff and the election officials who gave sacrificial national service to ensure safe and successful General Elections. The Vincentian electorates must also be commended for their involvement and the role they played to uphold democracy.

- x. Detailed instructions regarding the sealing of ballot boxes
- xi. Voting by election officials and police officers ahead of polling day
- xii. The official announcement of election results

IN EXERCISE of the powers conferred by section 33 of the Representation of the People Act, Cap. 9 of the Laws of Saint Vincent and the Grenadines, Revised Edition, 2009 the Cabinet makes the following Rules:

HOUSE OF ASSEMBLY ELECTION (AMENDMENT) RULES, 2020

- 1. These Rules may be cited as the House of Assembly Election (Amendment) Rules, 2020.
- 2. Rule 14 of the House of Assembly Election Rules is amended by inserting after subrule (2) the following subrule:

 Amendment of rule 14

"(3) For the purpose of the general election on 5th November, 2020, the poll shall be kept open for thirty minutes after the hours set out under subrule (2) only for persons who are:

- (a) eligible to vote; and
- (b) exempt from quarantine under section 5 of the Public Health (Port Regulation) (No. 2) Order 2020.".

1. Background

Pandemic outbreaks such as COVID-19 have the potential to destabilize and disrupt health systems and may have a profound effect on all aspects of a country's economy and the mental and physical health of the population.

On March 11th 2020, the World Health Organization (WHO) declared COVID-19 to be a Pandemic and as at October 25, 2020, there were 42,916,971 confirmed cases with 152,770 deaths across 213 countries (WHO Situational Report).

In St. Vincent and the Grenadines, the first case of COVID-19 was confirmed on March 11th, 2020 and as at October 25, 2020, there were seventy-three (73) positive cases, zero (0) deaths, with six thousand, six hundred and fifteen (6615) persons tested by RT-PCR. Additionally, more than four thousand (4000) persons throughout St. Vincent and the Grenadines have been screened for exposure to COVID-19, with no evidence of any exposure found.

The key objectives of this protocol are to educate, engage and empower people to ensure the safe conduct of General Elections in a manner that reduces the risk of the transmission of COVID-19. The protocol is based on the following proven public health measures:

- Wear facial coverings/masks when physical distancing is not possible;
- Keep a distance of six (6) feet from others;
- Wash your hands with soap and water or use an alcohol based sanitizer;
- Cough into a tissue or into the crook of your elbow;
- Avoid touching your face and
- Clean then sanitize surfaces (e.g. table tops, door knobs and cell phones).

The Health Protocol for the conduct of General Elections in St. Vincent and the Grenadines during the COVID-19 Pandemic were developed with guidance from CARPHA, the Centers for Disease Control and Prevention (CDC) and the International Foundation for Electoral Systems. 2. Objective:

To minimize the risk of transmission of COVID-19 during the conduct of General Elections in St. Vincent and the Grenadines.

3. Legal and Policy Framework

- a. Representation of the People Act, Cap 9 (Subsidiary Legislation) House of Assembly Election Rules
- 14. Poll to be taken by ballot
 - (1) The votes at the poll shall be given by ballot, the result shall be ascertained by counting the votes given to each candidate and the candidate to whom the majority of votes have been given shall be declared to have been elected.
 - (2) The poll shall commence at 7:00 a.m. and kept open until 5.00 p.m. and no longer.
- N.B. 'and no longer' is fixed by a Regulation, and not by the Act, and can be amended if a decision is taken to extend the time for voting to allow an hour for quarantined/isolated persons to vote. (AG's opinion)
- b. Public Health Act 2020
- c. The Public Health (Amendment) Act 2020:

Defines "Quarantine" – means the restriction of activities or separation from others of suspect persons who are not ill or of suspect baggage, containers, vessels or goods in such a manner as to prevent the possible spread of infection or contamination;

Section 27A. (1) Where a health officer is of the opinion, on reasonable and probable grounds, that –

- (a) A communicable disease exists or may exist or that there is an immediate risk of an outbreak of a communicable disease;
- (b) The communicable disease presents a public health risk; and
- (c) The requirements specified in the order are necessary in order to decrease or eliminate the public health risk presented by the communicable disease,

The health officer may be written order require a person to take or to refrain from taking any action that is specified in the order in respect of the communicable disease.

(2) In an order made under this section, a health officer may specify the time or times when or the period or periods of time within which the person to whom the order is directed must comply with the order.

Section 27C. (5) (Communication of order)

......the health officer may deliver a general notice to the members of the class through any communications media that the health officer considers appropriate......

4. Health Guidelines for the Conduct of General Elections

These guidelines apply to the conduct of General Elections in St. Vincent and the Grenadines. It is the responsibility of the Supervisor of Elections to inform the electorate of the requirements and to disseminate these guidelines to employees of the Electoral Office during the preparations for elections in St. Vincent and the Grenadines. Staff members of the electoral office (including poll-day staff, polling agents) must be trained, virtually, or in-person on the use of the following guidelines:

4.1.1 Polling Stations and other Facilities

- Signage outlining guidance for physical distancing, the use of face masks, hand sanitization, and cough etiquette are to be posted at highly visible locations within and outside of the polling stations and other facilities used during the election;
- A housekeeping schedule is to be established to incorporate routine cleaning and sanitization with regular, frequent, and periodic cleaning of equipment, seating areas (tables, stools, chairs and counters tops); all surface areas, restrooms and shared items;
- Cleaning and sanitization are to be done before opening and at the close of polls for polling stations and other facilities used during the election.
 Surfaces should be cleaned frequently throughout opening hours;
- 4. High-touch surfaces such as door knobs, tables, stools, chairs and restrooms must be properly disinfected on a frequent or periodic basis, using a bleach

- solution of 5 tablespoons (1/3 cup) per gallon of water (US 3.8L) or 4 teaspoons bleach per quart of water or 70% alcohol solutions or other EPA-approved disinfectant;
- 5. Hand sanitization facilities must/should be available at entry points to allow for the administration of 60% alcohol based hand sanitizer or the use of sinks with soap and water;
- Ensure that cleaning or disinfecting product residues are not left on table surfaces, as residues could cause allergic reactions or cause someone to ingest the chemicals;
- 7. Ensure proper ventilation throughout the polling station and other facilities used during the election. The use of air-conditioning should be minimized and outdoor air should be introduced by opening windows and doors;
- 8. Where possible, ensure disposable disinfectant wipes are available at all locations for use;
- 9. Periodically sanitize the electoral ink holder (receptacle);
- 10. Place garbage receptacles at strategic locations throughout the polling stations used during the election to allow persons to discard gloves, paper towels or disinfecting wipes.

4.1.2 Personal Hygiene

- Post visual alerts (e.g., signs, posters) at the entrance and in strategic locations inside and outside of polling stations used during the election, including restrooms, to provide instructions about hand hygiene, respiratory hygiene and cough etiquette. Instructions should include advising wearing a cloth face covering or facemask for source control, and how and when to perform hand hygiene;
- Endorse and encourage proper facemask etiquette when entering and exiting the
 polling station used for the election. Masks should be removed/lowered briefly
 with a sanitized hand to allow identification of voter. Six (6) feet distance
 should be observed during this procedure;

- Provide an adequate supply of 60% alcohol-based hand sanitizer or hand washing facilities/stations (fixed or portable), soap and running water; paper towels for use before entry. It would be ideal to have easy open-close taps or pedal actuated/hands-free taps;
- 4. Endorse and encourage proper cough and sneeze etiquette within the polling station either with a tissue or using the inside of their elbow; and
- 5. Encourage all poll-day staff, polling agents and electors to frequently wash hands and/or sanitize hands while at the polling stations and/or facilities used during the election. The use of touch-free technology for sinks, bathroom fixtures is encouraged. Elbow taps may also be used.

4.1.3 Poll-Day Staff, Polling Agent or Elector

- Encourage employees who are ill or who have had recent contact with a person with COVID-19 to stay at home. Poll-day staff who are ill or exhibiting symptoms of COVID-19 should not be allowed entry.
- 2. Strongly recommend the wearing of face coverings when entering the polling station and other facilities used during the election.
- 3. Notify health officials or call the COVID-19 hotline 534-4325 if a person becomes ill at the polling station or other facilities used during the election.
- 4. Where possible, establish procedures for safely transporting anyone who becomes ill, within the polling station and other facilities used during election, to the nearest public health facility.

4.1.4 Operations at the Polling Station

- 1. Provide physical guides, such as tape on floors and signage, to ensure that individuals remain at least six (6) feet apart at all polling stations.
- 2. Modify layout of the polling station, as necessary, to ensure employees and electors remain at least six (6) feet apart.
- 3. Establish a seamless voting process and layout that minimizes the risk of disease transmission through minimal interaction among electors,- poll-day staff and polling agents.

- 4. Institute measures to manage the number of persons within the polling station at any given point in time;
- 5. On entering the polling station
 - a. all electors are required to place their National Identification Card or other form of Identification on the desk of the Presiding Officer/poll-day staff.
 - b. all persons are required to wash their hands with soap and running water/sanitize their hands at stations (fixed or portable). Electors can utilize their own sanitizer.
 - c. All persons are required to temporarily take off their mask to allow for confirmation of identification by the election officer.
 - d. Before entering the voting booth persons are required to sanitize their hands.
 - e. Before placing finger in the electoral ink holder, persons are again required to sanitize their hands and dry them thoroughly with paper towel.
- 6. All poll-day staff, whose duties involve the use of paper such as binders, identification cards, poll cards and ballot paper are required to continuously sanitize their hands.
- 7. Pencils should be periodically sanitized by the poll-day staff.
- 8. The electoral ink holder (receptacle) must be sanitized periodically.
- 9. The poll-day staff member who is counting the ballots of electors should wear gloves and mask or face shield.

4.1.5 Operations of Special Voting for Quarantined and Isolated Positive COVID-19 Cases

Electors/voters, patients and health workers, who are isolated as positive COVID-19 cases, or on quarantine due to possible exposure to COVID-19 will be provided the opportunity to vote.

The Health Services Subcommittee of the National Emergency Committee will make available to the Electoral Office a list of the names of all Commonwealth travellers

18 years and older, arriving in St. Vincent and the Grenadines between the periods October 22, 2020 to November 4, 2020 and subsequently quarantined or isolated. The Electoral Office will issue a list of the eligible electors/voters who would in turn be provided with a temporary waiver of quarantine/isolation for a specified period on election day to vote.

a. Procedures at polling stations on election day:

- 1. All polling station workers and officials will wear face coverings/masks at all times and will regularly sanitize their hands or change their gloves.
- 2. All voters/electors should wear masks/face coverings while at the polling station.
- 3. Voters/electors should maintain at least six (6) feet of spacing while waiting in line to vote.
- 4. Hand sanitization will be implemented before and during the voting process:
 - a. Before the removal of face covering to allow for the verification of identity.
 - b. After the replacement of the face covering after the verification of identity.
 - c. Before dipping finger in the indelible ink well.

b. Procedures for electors/voters in quarantine (day 5 to day 14):

- 1. All eligible voters/electors under a quarantine order will be issued a temporary waiver of quarantine for a specified period (5:00 -5:30 pm) on November 5, 2020 to allow voting at the polling station allotted to them in accordance with the provisions made by, or under the Representation of the People Act, Cap. 9.
- 2. All eligible voters/electors granted a temporary waiver of quarantine must wear a face mask for the entire duration of the period out of their quarantine site and follow all instructions in terms of spacing and sanitization.

3. All eligible voters/electors granted a temporary waiver of quarantine must travel to the allotted polling station and from the allotted polling station in a vehicle which allows sufficient spacing between the suitably masked elector/voter and the suitably masked driver.

c. Procedures for electors/voters in quarantine (day 1 to day 5) and in isolation:

- 1. All eligible voters/electors under a quarantine/isolation order will be issued a temporary waiver of quarantine/isolation for a specified period (5:00-5:30pm) on November 5, 2020 to allow voting at the polling station allotted to them in accordance with the provisions made by or under the Representation of the People Act, Cap. 9.
- 2. All eligible voters/electors granted a temporary waiver of quarantine/isolation must wear a face mask for the duration of the period out of their quarantine/isolation site and follow all instructions in terms of spacing and sanitization. All polling station staff will wear full PPE (gown, mask and gloves) while interacting with these electors/voters.
- 3. All eligible voters/electors granted a temporary waiver of quarantine/isolation must travel to the allotted polling station and from the allotted polling station in a specially identified vehicle which allows sufficient spacing between the suitably masked elector/voter and the suitably masked driver.

The Supervisor of Elections and the Attorney General shall determine the specific time period to be assigned for voting on November 5, 2020, by eligible electors/voters in quarantine or isolation. During this specific time period, only electors/voters in quarantine or isolation will vote. There will be no mixing of electors/voters in quarantine or isolation with the general electors/voters.

4.1.6 Responsibility of Electoral Office

 Establish a seamless voting process and layout that minimizes the risk of infection through minimal interaction among electors, poll-day staff and polling agents;

- 2. Promote healthy hygiene practices at the polling station and other facilities used in the election at all times including the wearing of masks;
- Intensify cleaning, sanitization, disinfection and ventilation of the polling station and other facilities used in the election process;
- 4. Encourage physical distancing and ensure spacing of at least 6 feet between electors at the polling station and other facilities used in the election process;
- 5. Train all poll-day staff and disseminate guidelines to the electorate for ease of understanding and practice during the election process;
- 6. Advise staff members to remain at home if ill. Train additional staff to fill staffing gaps on election day.
- 7. Provide proper signage for electors regarding physical distancing, location of sanitizer/ hand washing station, requirements for mask wearing, cough etiquette); and
- 8. Institute measures to manage the number of persons within the polling stations used in the election process at any given point in time.

4.1.7 Responsibility of the Elector

Strictly adhere to these guidelines prior to use, during use and upon exit from the polling stations and other facilities used in the election process including:

- hand washing and/or sanitizing prior to the entire voting process,
- strongly advised use of personal masks when entering and exiting the polling station and during the entire voting process;
- physical distancing of six (6) feet apart prior to and during the entire voting process

5. Implementation of the Guidelines

The Chief Medical Officer, the Honorable Attorney General and the Supervisor of Elections will agree on the draft Health Protocol for the conduct of Elections in St. Vincent and the Grenadines in the COVID-19 Pandemic. The draft Health Protocol will be submitted to the Christian Council and all political parties contesting the General Elections for their consideration. The final version of the Health Protocol will be agreed on by the Supervisor of

Elections. Subsequently, the Supervisor of Elections will then disseminate the Health Protocol to all election officers and electors to ensure their effective implementation and compliance. Thereafter, continuous assessment by the Electoral Officer on the adherence of these Guidelines should be implemented to ensure strict compliance.

<u>PROTOCOL FOR SPECIAL QUARANTINE ARRANGEMENT: WORKING QUARANTINE – CARICOM ELECTION OBSERVATION MISSION (EOM)</u>

AIM:

The safe completion of an Election Observation Mission (EOM) for the General Elections on November 5, 2020, in a manner that reduces the risk of the importation and subsequent transmission of COVID-19 in St. Vincent and the Grenadines. This protocol will allow each member of the Election Observation Mission free movement between their accommodation sites (quarantine sites) and all sites/locations (working quarantine sites) required in the execution of their duties.

OBJECTIVES:

- 1. Establish the status of exposure to COVID-19 of the members of the EOM.
- 2. Ensure the safe implementation of the tasks of the Election Observation Mission within the quarantine period of 14-21 days.

INFORMATION REQUIRED FOR EACH PERSON WHO SHALL COMPLETE A WORKING QUARANTINE AS PART OF THE EOM:

- 3. Full name, date of birth, passport number, contact number and address in departing country.
- 4. Arrive with a negative SARS-CoV-2 RT-PCR result (72 hours).
- 5. Address and contact information of the proposed worksites (polling stations, community sites, electoral office, etc.).
- 6. Address and contact information for proposed accommodation sites (hotel, guest house).
- 7. Commitment of contracting organization/company or individual to pay for the accommodation at the approved quarantine site.

ESTABLISH RISK OF ARRIVING TRAVELLER:

The arriving EOM member will:

- 1. Complete the Pre-Arrival Form available at health.gov.vc And the Port Health Officer will:
 - 1. Complete the Port Health form for each member of the EOM.

CONDITIONS OF QUARANTINE IN ST. VINCENT AND THE GRENADINES:

- 1. A court order for quarantine for 14 days may be issued indicating the approved sites of working quarantine to include the accommodation and all possible working sites.
- 2. The members of the EOM under working quarantine will be allowed to be present at all sites required to complete their duties/tasks.
- 3. The members of the EOM will be allowed to travel between the approved accommodation and working quarantine sites in an approved vehicle with an identified driver.
- 4. The members of the EOM will at all times observe all of the hand hygiene, cough etiquette, physical distancing and safe mask use guidance of the Health Services Subcommittee.
- 5. Each member of the EOM will keep a daily log of their measured temperature and the appearance of any COVID-19 signs and symptoms, and report this information on a daily basis to an assigned Healthcare Worker.
- 6. The approved working quarantine sites (accommodation and work) will observe the Health Services Subcommittee guidelines for the provision of meals, cleaning and general interactions.
- 7. The Health Services Subcommittee may request that a COVID-19 test be conducted at any time during the working quarantine period.
- 8. If at any time during the working quarantine period any member of the EOM develops any signs or symptoms of COVID-19 or tests positive for COVID19, all approved working quarantine will cease immediately. Isolation of symptomatic or COVID-19 positive persons will be in effect immediately. Any restart of working quarantine must be approved by the Health Services Subcommittee.
